# IMPORTANT INFORMATION

## Notice of Fingerprint-Based Criminal History Records Check

After July 1, 2018, all individuals licensed by the Mississippi Real Estate Commission (MREC) will have completed a “Licensing Cycle” in which a Criminal History Records Check based on the submission of fingerprints to the MREC was received. **Beginning with the July 31, 2018 Renewal Date**, applicants for renewal of any real estate license will **NOT** have to submit a new fingerprint card. The MREC will use your Original Card to submit to the Department of Public Safety and the Federal Bureau of Investigation.

### **Submission of Renewal Form, Criminal History Acknowledgment and Fees:**

Enclosed with this Renewal Notice is an envelope **addressed to the MREC** for the return of the documents included in the mailing. If you mail the documents in a different envelope, please use the following address:

Please return the executed Renewal Notice (Signature required on the back of the notice) and the renewal fee in the form of a check or negotiable instrument. The renewal fee for a Broker is \$150.00 and the renewal fee for a Salesperson is \$120.00. Please return the completed and executed Consent Form along with a **separate** check or negotiable instrument in the amount of \$50.00. **Separate checks are required but each should be made to the MREC.**

When received, the MREC will electronically submit your **Original Fingerprint Card** to the Department of Public Safety Criminal Information Unit (CIU) to process a new background check of the Mississippi and Federal databases.
